

On April 13, I made a presentation at the Public Works Institute on Public Works role in Emergency Management. Larry Frevert and I were speaking prior to my presentation, and he informed me that one of the class members had one of their governing body members tell him that Public Works wasn't a first responder and that they should remove the first responder patch from his shirt.

FIRST RESPONDER

Public Works is a lot of things, but one thing we constantly fail at is publicity. We have never been very good at patting ourselves on the back or being front and center when the TV crews show up. We have to do better. APWA started a campaign in 2017 to help get us recognized as a first responder. If anyone in your organization needs clarification, documentation or proof that Public Works are recognized as a first responder, please direct them to Homeland Security Presidential Directive-8 (HSPD-8) which can be found here: https://irp.fas.org/offdocs/nspd/hspd-8.html or on a google search. HSPD-8 came out of the George W. Bush White House in 2003. In the definitions section of HSPD-8 it defines first responders as:

(d) The term "first responder" refers to those individuals who in the early stages of an incident are responsible for the protection and preservation of life, property, evidence, and the environment,

including emergency response providers as defined in section 2 of the Homeland Security Act of 2002 (6 U.S.C. 101), as well as emergency management, public health, clinical care, public works, and other skilled support personnel (such as equipment operators) that provide immediate support services during prevention, response, and recovery operations.

Public Works will be on the scene long after the event has subsided restoring lifelines like street access, storm water, debris removal, etc. and helping the community get back to normal. Just remember, your work is VITAL during emergency management.

April is Safe Dig Month

Spire reminds customers to 'Call Before You Dig' During Safe Digging Month in April



Call 811 before putting a shovel in the ground for spring projects

Kansas City, MO (March 30, 2022) — Spring is in full bloom, and more people are heading outdoors to do projects that involve digging, such as planting a tree, building a deck or installing a mailbox. That's why Spire and utilities across the country encourage residents during National Safe Digging Month in April to call 811 before digging to help prevent accidents involving utility pipelines.

April is Safe Dig Month — cont.

"If you're putting a shovel in the ground at any depth, you need to call 811," said Alan Meyer, Spire manager of damage prevention. "When you place the free call to 811 a locator will mark the utilities within the requested area saving you time, money, and even lives. It is also important to remember to wait the appropriate time for utilities to respond before beginning your excavation."

According to the U.S. Department of Transportation's Pipeline and Hazardous Materials Safety Administration, if someone calls 811 before they dig, they have a 99% chance of avoiding contact with a utility pipeline, which can lead to injury, death or harm to the environment. Whether a bush is being planted or a foundation is being laid, calling 811 at the beginning of a project can help keep an entire neighborhood stay safe.



That's why Spire recommends four steps for safe digging:

- 1. Dial 811 to request a site be marked. The call and the locating services are free.
- 2. Call at least three days before digging. A locator will mark lines that could be impacted by your project.
- Spire lines will be marked with yellow flags and/ or spray paint.
- 4. Be careful when digging around the markers to avoid accidentally damaging buried natural gas or other utility lines.

Meyer said that even when individuals follow rules and regulations closely, accidents can still happen. If a pipeline is ever damaged:

- Never try to stop or slow down the flow of natural gas
- Move to a safe distance upwind of the damage
- Keep others away from the area
- Never try to move equipment from the area
- Call 911
- Call Spire
- Call 811, a nationwide toll-free number, to report the damage

"At Spire, safety is our top priority, and we encourage customers with questions to contact us," said Meyer. "We always do whatever we can to help people protect themselves, their communities and the environment." 
KC Metro Standards Section 5600 Update

The APWA Executive Committee approved the process to update regional stormwater design standards and the MARC/APWA BMP manual in October 2021, upon the recommendation of the Sustainable Stormwater Task Force. The process will launch this summer and is expected to take approximately two years to complete. To date, twenty communities have pledged financial support for the effort.

The Mid-America Regional Council (MARC) will facilitate and administer the process, which will include the development of a request for proposals, selection of a consultant team, management of the consultant contract through to final acceptance by APWA KC Metro Chapter, and the facilitation of community and stakeholder participation. The selected consultant team will be managed by a steering team made up of APWA KC Metro Chapter municipal representatives and appropriate community stakeholders.

Local stormwater infrastructure design standards were last updated in 2003. A compelling need exists to update regional stormwater standards to be more resilient and adaptive, in part by linking stormwater quantity and quality. The scope of work, which will be refined by the project steering committee, is expected to:

- Create a set of stormwater standards that are more adaptable
- Combine water quantity and quality design standards
- Include development and redevelopment standards
- Address resiliency and sustainability by promoting more holistic system evaluations
- Update rainfall standards and other appropriate hydrology methods
- Increase the level of hydrology and hydraulic evaluation requirements
- Reduce the existing subjectivity in technical assumptions
- Provide more natural system design criteria, and
- Improve the evaluation of stormwater detention requirements for increased value.

Public Works Institute April 12-14, 2022

The Kansas City Metro Chapter held its 18th Public Works Institute (PWI) *Public Works Supervision Skills* on April 12-14 at the Lodge at Ironwoods, Leawood, KS. Thanks to Dennis Banka, Leawood Public Works Superintendent and other Leawood staff for making this facility available at no charge to the chapter. This allowed us to keep the registration fee at \$250 again this year.

The class was welcomed to the PWI training on the first morning by Chapter President Alysen Abel and to Leawood by the Honorable Peggy Dunn, Mayor of Leawood.

85 individuals, our largest ever attendance, for the three-day training and presentations by many of the region's public works directors and senior public works staff. This attendance brought us to a total of 331 public works professionals who have attended at least one three-day PWI since the chapter began the program in 2011. Through 2021, the chapter had graduated 188 professionals from our PWI (which requires attending all four of the three-day training modules). Six more persons (shown in the photo below) completed the requirements for graduation in this latest PWI and will be recognized as 2022 graduates.

This spring's attendees came from 33 municipalities (12 Missouri and 11 Kansas), as well as Jackson County, MO and UGWYCOKCK. We also had 10 out of region attendees from Jefferson City and Warrensburg, MO and Hutchison, KS. This spring's PWI attendance included 27 people attending their first PWI.

PWI Module III – *Public Works Management Fundamentals* is planned for October 2022. Watch for advance details on the event on the chapter's website as early as August with registration beginning September 1.


