Approximately 40 delegates were in attendance along with National staff and President-Elect Elizabeth Treadway. requirements for Public Works Supervisor, Public Works Manager and Public Works Executive so it is premature to speculate on the impact on the institutes. It may be necessary to "tweak" our curriculum once the credentialing requirements are finalized but the institutes will still be a very viable program for the Chapters.

National is moving forward with the Institute of Sustainable Infrastructure to develop a national standard, called 'Envision', to rate the sustainability of projects. Envision will be a broad based program covering multiple project areas including energy, water, waste, transportation, landscape and information. # TECHNO MINUTE

FROM MIKE ROSS

This is a follow-up article regarding the use of Android tablets as a field data collection device. Last year I was excited with the capabilities of the Android tablet devices that we were planning to use for our upgraded pavement management program. As you read this, our summer inspections will have passed the half-way point. I'm pleased to report that the tablets are even better than I had imagined – they have actually improved our inspection process. We're now developing software to use them for other field inspection applications.

We're using Samsung Galaxy Tab 10.1 devices. These run Android version 3.2, code named "Honeycomb." I developed a custom application for our inspection process using Basic4Android (<a href="http://www.basic4ppc.com">http://www.basic4ppc.com</a>), an inexpensive integrated development environment that uses a dialect of basic that will feel fairly comfortable to anyone familiar with Microsoft Visual Basic. The tablet has a 5



megapixel camera and a GPS sensitive enough to get a position from the desk in my office (near a set of west facing windows). I'm using SQLlite to store and present data in the application. This is an open source and free version of SQL that seems ideally suited for this type of application. Our pavement evaluators email their daily results to an Overland Park email address at the end of each day, and weekly, we connect the tablets to a PC with a USB cable and download the photos they've taken of the street sections they inspect. We perform COE PAVER inspections, and thus inspect randomly chosen samples of roadway sections that are homogenous in construction, age and traffic. The number of samples varies with the size of the street section, but on average we'll inspect about 15% of our network. Three two-man teams of engineering students will inspect several thousand samples over the summer. We will inspect all of our non-thoroughfare roads every two years using this process.

The photographs provide a significant improvement in the process. Our pavement management system models deterioration for the various classes of pavement we have in our inventory and can forecast a condition coincident with the date of the actual inspection. We generated a report that compares actual with forecast pavement condition, and armed with the history for any given street section, the maintenance history, and the photographs, we can rapidly perform inspection quality control checks. We've told our engineering students to photograph the sample unit and any unusual distresses. The application stores GPS coordinates with each photo and labels each .jpg with the name of the section and sample. We're keying each set of photographs for any given section to the inspection, and we can view these photographs easily from our pavement management system. In future years, we'll be able to view historical photographs and compare them to get a visual indication of deterioration over time.

Having GPS locations is another new feature. It gives us the ability to define each sample unit by the boundaries roughly established by the recorded coordinates, but it will take some time to gather these coordinates for all of our streets and then turn them into definitions. Once that's done, we can use them to use GPS to suggest the identity of the sample unit, rather than requiring the user to enter each one. The GPS accuracy varies somewhat, but the vast majority of recorded points are accurate within 20 ft.



Several years ago we began tracking work orders against street sections. As a result, we can also see whether our maintenance division has done work on the street. In PAVER, any filled crack is a low severity distress. Crack sealing alone can boost the PCI for the street. In the past, we'd see an unexplained improvement in condition. Now that our maintenance crews document their work, we have a complete history, including ad-hoc and programmed work and the photo confirmation gives us a level of confidence in the

inspections we haven't had before. Our inspections still aren't perfect, but we now have tools that allow us to quickly separate the good from the bad.

The economic downturn has forced us to live closer to the bottom of the "good" rating while managing our pavements (the \$1 point in the graph to the right). Allowing our pavements to reach that condition makes the accuracy of the condition inspections that much more important.

The screenshots below this article show for a typical street the history (from several databases) (image 1), a history plot showing historical condition and programmed maintenance activities (image 2), one of several photographs



taken of this particular section (image 3), and a map showing one of the samples inspected and the distresses found for that sample (image 4). Note that locations are where the evaluator was standing, within the accuracy of the built in GPS, not necessarily where the distress was located.

You may wonder why we're using an Android tablet instead of the very popular Apple iPad. The simple answer is that Android is an open source operating system and is easier for us to develop for. Unfortunately, PCWorld reported on June 27<sup>th</sup> that "Apple is on a patent tear winning an injunction that bans sales of the Galaxy Tab 10.1 tablet in the United States." What that means to us is yet to be seen, but all Android devices may need to change in order to comply with Apple's patents – which may require some re-development of our tablet application.

What all of this means to Public Works is that much like the personal computer changed the way we did business in the 1980s, tablet computers and smart phones will change our business in the years ahead. The portability of these computing devices coupled with their ability to record sound, images and locations makes them a very useful tool for those of us that maintain stuff scattered all over the planet (or at least our little corner of it).




Image 1 - Street History, showing layers, condition history and proposed maintenance treatment




Image 2 - Condition Plot (red lines) note that condition is assumed to be 100 immediately after treatments (vertical lines)

# WHAT'S NEW REVIEW

Innovative Design-Build Road Maintenance Strategy: A Proven Direction for Kansas City (winner of KC Metro Chapter Management Innovation Award)

The City of Kansas City has a population of approximately 450,000 people, a quarter of the metropolitan area population. The City maintains approximately 6,200 miles of roadways with an annual budget of \$60 million. Much of the City's infrastructure is 50 to 100 years old and is in dire need of rehabilitation.

In 2004, the City established design-build as an alternative construction delivery method in the City Charter. In June 2010 the City Council passed a resolution to fund \$33 million for street maintenance and waterline repair/replacement. Twelve arterial roadway segments were identified in the resolution, each less than one-mile in length. There had not been any design completed for any of the projects. Within a period of four months, Requests for Proposals (RFPs) had to be submitted, contractors selected and Notices to Proceed issued by the end of 2010. There was a realization that the standard method for project delivery could not accomplish the objective. With this time constraint, a new and innovative process was developed to meet the City Council's requirements for the procurement and implementation of the projects incorporating design-build project delivery.

#### PROGRAM DEVELOPMENT

Over a four-month period the City of Kansas City Public Works Department and Wilson & Company, Inc., Engineers and Architects (Wilson & Company), worked diligently to develop and administer a program that entailed:

- Establishing RFP and contract documents with the Purchasing Department
- Defining the scope of work to be completed for each project to meet the desires of two departments:
  - Public Works Department Roadway, Traffic/ADA, Sidewalks/ADA
  - Water Department Waterline, Sanitary Sewer, Storm Sewer
- Developing the technical requirements for the Design-Builder and their Designer of Record to adhere to
- Creating a procurement process based on a Best Value project selection including qualifications, experience, technical approach, commitments made and cost evaluations.

The City released projects in two separate RFP packages. The initial package for the first set of five arterial roadway reconstruction projects was advertised within two months of the design-build program being conceived. The Design-Builders were allowed to propose on any combination of the individual projects.

A best value selection process was used incorporating both technical evaluation and bid cost evaluation of the proposals. It was a single step process, without short-listing, and without stipend compensations to the proposers. The technical scoring accounted for 60% of the total score and included qualifications and experience, project approach and commitments, maintenance of traffic and project schedule. The bid cost evaluation accounted for 40% of the total score and was determined by a set formula based on the bid price relative to the lowest bid price.

Through an expedited process, a mandatory pre-proposal meeting was held to explain the process; proposals were submitted (23 in total), reviewed and scored; selections were made; and recommendations were taken to City Council.

### PROGRAM REFINEMENT

As with any new process or program, refinements should be made to address issues that arise during the initial roll-out. In response to this need, a Design-Builder forum was conducted for the Design-Builder community to voice concerns and questions about the process. The forum went through the details of the requirements, scoring process and expectations. The design-build teams were given direct feedback to their questions, which was well received. Contractors asked the City to provide additional clarification regarding how scores were developed, and suggested a different process on how the weighting could be distributed. They also identified items they felt substantially increased their risk, which in turn, increased the bid amounts.

With this information, the City of Kansas City and Wilson & Company worked to refine the process to address comments and develop a plan to reduce the risk to the Design-Builder while providing the City with an excellent product. Adjustments were made to the technical scoring criteria and additional information was provided to the Design-Builders for the second set of projects to reduce their risk and increase the value to the City.

#### RESULTS

The refined program resulted in fewer questions for the second set of projects. The design-build teams were more aggressive and provided greater value and additional commitments above and beyond the project definitions, including: additional sidewalk work, a new pedestrian signal, concrete bus pads, open drainage improvements, and timing of construction to coincide with other area activities (school, events, etc.)

The City believes the program was a success in several areas, including:

- Maintained or improved project quality
- This process reduced the typical design-bid-build time period by months
- Allowed for additional improvements to be completed within/under budget at the same time as defined work in the RFP
- Provided a coordinated approach to infrastructure corridor improvements (road, water, sewer, traffic, etc.)
- Significantly reduced conflicts between design and construction, change orders and schedule delays (both for design and construction) and "scope creep" by defining project and requirements
- Reduced procurement and management staff resource needs by combining design and construction in one RFP package
- Reduced City Council review time approval of one project versus multiple contracts
- Increased the efficiency of taxpayer funds

### LESSONS LEARNED

Developing this design-build program required an incredible amount of interdepartmental communication and cooperation. Within the contract documents, both the City and the Design-Builder were held to schedule requirements for both submittals and reviews. Maintaining the communication and cooperation throughout the process was essential for the program to be successful.

It was clear from the first procurement that it was critical for the process to be kept "simple," both in terms of the Technical Requirements and the Scoring. For technical requirements, the definitions for the work to be performed had to be defined in a manner that allowed the Contractor to propose a more efficient or effective method to exceed the requirements. This was much more apparent in the second round of RFPs which resulted in a more competitive Best Value Selection.

It was evident that there is a level of baseline investigation and information that should be provided by the owner to reduce the Design-Builder risks and contingency pricing while not providing a stipend. Providing the Design-Builders with critical information such as right-of-way drawings, aerial photography, pavement core samples and waterline maps significantly decreased the amount of risk to the Contractor, and provided the Design-Builder enough information to develop alternatives. This information was critical to allow the Design-Builder teams to propose alternative approaches that resulted in:

- Cost savings, better maintenance of traffic
- Coordinated replacements of waterline, storm sewer/sanitary sewer, roadway and sidewalk
- Upgrades for traffic management such as ADA ramps and buttons, traffic detection equipment and transit accessibility

Finally, having a solid understanding of staffing requirements was critical for the program's success. As identified earlier, staff from several departments had to be integrated into the process for Contractor plan submittal approvals. This included materials testing, construction management, lighting staff, traffic control/timing, water valve shutoffs, etc. Communication and coordination made this project a success.

## **NEXT STEPS**

The City of Kansas City anticipates using this process for at least 80% of their future roadway reconstruction work. This process was successful as viewed by staff, management, elected officials, Design-Builders and their construction teams, and the community served by these upgraded facilities.

In early February 2012, Mayor Sly James presented a program to obtain \$1 billion in bonding authority for investment efforts in the Kansas City core to enhance the aging neighborhoods and promote economic development within the City. Through this street maintenance design-build program, the City has developed a proven methodology to effectively and efficiently deliver a roadway reconstruction program of any scale, and can support the Mayor's investment program. This process has changed the way the City of Kansas City, Missouri conducts business with its contractor and engineering community.

Typically, up to five \$1000 scholarships are awarded per academic year. The scholarship fund currently has a balance of approximately \$130,000 which is used to fund the annual scholarships. This spring, the Scholarship Committee received ten applications for the 2012-2013 scholarship awards and after careful evaluation recommended scholarships be awarded to six very worthy candidates. Since one extra award was being recommended (typically up to five scholarship are recommended), the past president members of the Scholarship Committee reached out to their fellow past presidents to pool funds and issue a challenge to match contributions from attendees of the NPWW luncheon. The membership responded and over \$1000 was collected. This allowed the award of the extra scholarship, providing help to one additional eligible student-candidate, without impacting the fund principle.

## **Education and Training Committee - From Jason Meyers**

Burns & McDonnell hosted a Click, Listen and Learn training on June 26<sup>th</sup>, 2012. This event brought together 36 attendees from the public and private sectors. Each attendee received **two hours of professional development**.

The topic presented was "Updates to the AASHTO Green Book."

The sixth edition of AASHTO's publication "A Policy on Geometric Design of Highways and Streets" -- popularly known as the "Green Book" and the leading U.S. practice guidance for geometric design -- will be published this fall. The American Public Works Association has participated in the update of this key engineering design document.

State transportation departments, working through the American Association of State Highway and Transportation Officials (AASHTO), develop design standards through a series of committees and task forces in coordination with the Federal Highway Administration (FHWA). Probably the most frequently used document generated from this process is the Green Book. This 1000+page document is published by AASHTO and serves as this nation's primary highway and street roadway geometric design reference.

Federal law provides that design standards for projects on the National Highway System (NHS) must be approved by the U.S.DOT in cooperation with the State highway departments, and the Green Book has been adopted for this purpose. Federal law also requires that projects other than highway projects on the NHS shall be designed, constructed, operated, and maintained in accordance with State laws, regulations, directives, safety standards, design standards, and construction standards. Since most state DOT guidance is derived from the Green Book, much of the design guidance and standards used by local governments also evolve from the Green Book.

The presentation addressed the history of the Green Book, major changes in each chapter of the new book and discussed the use of updated design guidance and design flexibility throughout the document.

After viewing this program, participants:

- Expanded their knowledge of geometric design.
- Comprehension and application of the latest design policy guidance from AASHTO.
- Increased ability to perform geometric design to current policies and discern how to apply design flexibility.

Cost of the program was \$15 and included Rosati's Pizza.

Beginning July 1st, all APWA members will see a significant increase in the value of their membership.



## Johnson County Dedicates 'Green' Fleet Facility

Article from Government Fleet Top News issued June 4th, 2012

Johnson County officials dedicated two new buildings on May 30<sup>th</sup>, a 22,250-square-foot, eight-bay fleet maintenance building and a 23,300-square-foot administration/operations building. The total project authorization was \$14,560,000, according to a release from the County. Construction of both buildings began December 2010. The fleet maintenance building was completed in January and the administration/operations building in March.

The fleet building has eight maintenance bays and one wash bay. Fleet technicians service about 120 vehicles, the vast majority of which are Public Works heavy equipment. The County fleet staff of five technicians has already fully transitioned into the new building, Joe Waters, director of the Facilities Department, told *Green Fleet*.

Some of the "green" features in the buildings include the following: a geo-exchange system that utilizes the ground under and around the building to assist in heating and cooling the office and operations areas; natural lighting for the main office and training area, which passes through insulated windows; and landscaping features that keep rainwater on-site, where it's used to water vegetation rather than end up in storm drains. Each building has a FEMA storm shelter to provide safety for the Public Works employees working at the complex.

"The existing...site, much of which is an old limestone rock quarry, is fronted on a state highway on the fringe of the city. The old Public Works and Fleet building had just three service bays and was located along the highway, but the new buildings have been placed to the rear of the property in the quarry," Waters said.

The old building has since been taken down, and Waters said the County has plans to build a second compressed natural gas (CNG) fueling station there, expected to be completed by first quarter of 2013. The first CNG station, in the northern part of the County, is expected to be completed by the end of 2012. Both are partially funded with grants.

The county anticipates LEED Gold certification for the two new buildings from the United States Green Building Council under the council's Leadership in Energy and Environmental Design (LEED) Green Building Rating System. LEED certification is the nationally accepted benchmark for the design, construction, and operation of high-performance sustainable buildings.

Johnson County currently has three LEED Gold buildings and one LEED Platinum building.
