TECHNO MINUTE

FROM MIKE ROSS

I believe that most of the cities require a professional engineer to design or approve street improvements, but I have encountered various city officials that feel that engineering adds unnecessarily to the project cost for street maintenance – especially where they felt that they knew exactly what was needed. If it is true that engineering adds to the cost of our infrastructure projects, I'm embarrassed for the engineering profession. Competent engineering should solve problems in a way that protects the public's interest and safety and that ultimately saves money for the client. This should be true whether the engineer is a staff engineer or an outside consultant. That engineers are considered by some to be a wasteful expense is a bitter pill for me to swallow.





Taking the simple overlay project, here are several questions that should be answered:

Is the base of the road structurally sound? If there are base failures, should these be spot repaired, or should the entire base be replaced? Is there a subgrade issue that may have contributed to the failed section? Are there utilities, such as manholes or valve covers, that need to be adjusted? Since this is an overlay subject to ADA requirements, do sidewalk ramps need to be constructed or reconstructed to comply with the current requirements? Are there pavement markings? What is the appropriate material to replace them with? How long will they be gone, and should temporary markings be installed? Should the markings be replaced as they were, or has the MUTCD changed? What material should be used for the overlay? Are the speeds or volumes high enough to require additional skid resistance considerations? Is the road profile adequate, or should the milling operation reshape the profile to restore appropriate cross slope or section? If the profile is being changed, do the varying thicknesses require the use of a "wedge" course, or can the material be placed in one lift? If a wedge course is used, should the asphalt spec be changed to allow for thinner lifts? Are there drainage issues that need to be addressed, especially at intersections? Are there sections of curb or shoulder that need to be replaced with the overlay? Are there traffic control inductive loops that will need to be replaced?

Despite the long list of questions above, the design of a treatment is a fairly simple process. Selecting the appropriate treatment, recognizing how effective the treatment will be, what the return on investment is and setting the timing for the treatment to better manage the street network is a more complicated process. Most folks employ what they consider common sense and then wait until the road has failed to apply some treatment. Worse, they prioritize maintenance so that the worst roads are their highest priority. By doing so, they may spend their entire budget on a few failed roads ignoring the maintenance necessary to keep their good roads good using inexpensive surface treatments.

Street maintenance done right requires the creation of an inventory; it requires a system of measuring condition that is consistent, accurate and repeatable; it requires the discipline to perform measurements frequently enough to be able to use the data to accurately predict future conditions; and it requires the mathematical skills necessary to optimize treatments so that the condition of the overall network meets some goal. Benefits of pavement management systems include the ability to evaluate the effectiveness of treatment methods and ultimately will provide the most cost effective method for maintaining a road network.





will vary with the individual road network and class of roadway, but the concept is that it is less expensive to maintain the surface of a road than it is to maintain the lower layers. The \$1.00 point corresponds to the lower limit for "good" which happens to be a PCI of 55 in PAVER. The "Will cost \$4.00 to \$5.00" point is at a location on the curve that is better than "failed." In our experience, surface treatments are at least 50 times less expensive than total reconstruction.

The two photographs below are of Lamar at about 65th Street. It was inspected on June 4th of this year. The pavement condition index (PCI) for this street was a 54.4 at the time of the inspection. In PAVER, this is the "point of no return," also the "\$1.00 for renovation here" point on the graph. The rate of deterioration will accelerate, and the cost of restoring this road to very good condition will increase if maintenance is deferred past this point. An inexpensive surface treatment now will save some costly base repairs later. Note that this road looks fairly good – in PAVER it is just below the lower limit for a "good" rating.

The photograph below is of another street in the area, taken in mid June. This street has a PCI of 0.0. That PCI corresponds to a road with no salvageable structure left. In order to restore this road to like new conditions, it would need to be rebuilt from the dirt up. As it happens, and thanks to a complete history of every road in town, we know that this road was built 60 years ago using a Mission Township standard that would not satisfy any reasonable or recent design process. It's lasted 60 years so, despite that fact, you could argue that it has performed very well – although we don't know how many times it has been patched over the past 60 years (we only recently started to keep that information). This 0.0 PCI corresponds to a "failed" condition. Unfortunately, this is the condition point that most of our residents would start paying attention to – a condition reached years after the roads condition passed through a PCI of 55. Because it doesn't have potholes, some would consider crossing their fingers and overlaying this street. They would discover in a few short years that the road was back to a failed condition as the cracks visible here reflected back to the surface due to the lack of structure in the base layers.



So while it may be true that the wrong solution to a particular problem is less expensive if an engineer isn't used, and some correct solutions are arrived at by blind luck and without an understanding of the issues involved, the right solution, based on a competent engineering analysis, coupled with a cost analysis that looks at alternatives, will save money over the long term.

Perhaps we should adopt the proverb used by attorneys: "A man who is his own *engineer* has a fool for a client"

Sadly, like attorneys, we engineers are sometimes viewed as an unnecessary expense.

Severe Duty and Heavy Duty Snow Plow Competitions

We are proud to announce the addition of a brand new event to the 2015 Expo: The American Equipment Company **Heavy Duty (HD) Snow Plow Competition**. This event is aimed at another important segment of the snow fighting contingent, those 1-ton trucks equipped with plows and spreaders we rely on to clear parking lots, clean up culde-sacs, and clear side streets. We are excited about offering an opportunity for a new group of municipal operators to demonstrate their skills! The rules for this new event are as follows:

- Truck GVW shall not exceed 19500 lbs (Ford F550, Ram 5500)
- Truck GVW shall not be less than 8500 lbs (Ford F250, Ram 2500, Silverado 2500)
- Truck can have single or dual rear wheels
- Truck can be configured with a standard truck bed, flat bed, dump bed, or combo body.
- The truck shall be equipped with a V-box spreader in the bed or configured for spreader operations if combo body
- Material in the spreader box is NOT required, but permitted
- The plow will be a straight blade with a minimum width of 8' (measured at the bottom of the moldboard)
- A V-plow may be used, but must be used as a straight blade with an 8' minimum width (measured at the bottom of the moldboard)

The addition of this new event necessitated a new name for our legacy Snow Plow Competition, now known as: The American Equipment Company Severe Duty (SD) Snow Plow Competition. Rules for this event remain unchanged and are available on the following page.

These events will take place on the same course with the same scoring criteria. However independent scoreboards will be maintained for each event. Scores for the new event will contribute to the overall team championship trophy like all other events.

The Public Works Directors Snow Plow Competition

For the Friday Finale there will not be a snow plow run-off. The SD and HD Snow Plow Competitions will be finalized on Thursday. For this year, the Snow Expo Committee is introducing a new twist, **The Public Works Directors Snow Plow Competition**, where the Directors will have the opportunity run the same snow plow course their personnel did and have their scores count towards the team trophy. The rules:

- All competitors will operate the same 1-ton truck fitted with snow plow and spreader.
- If the Public Works Director is unavailable, a substitute may be made, but they <u>MUST</u> be a Municipal Administrative employee (relying on the honor system with this one)
- If the Public Works Director does compete, it is worth a 5 point bonus to his/her team's final score.
- The competitor may have one of their Municipality's normal plow operators accompany them as co-pilot to talk them through the course, but they are NOT allowed to assist in any other way.

This event is a fun way to include those individuals who allow this event to happen, and we look forward to seeing them on the course!

Severe Duty (SD) Snow Plow Competition Rules & Regulations

Each driver must be registered prior to the beginning of the event competition. Seat belt use *is required!* A minimum of 12 participants is required in each event or only the first place finisher will be awarded the 2015 destination prize. Vehicles and equipment used in all events **except snow plow** will be provided by the vendors.

Severe Duty Snow Plow Vehicle Rules

The vehicle must be one standard configuration dump truck with a cab-to-axle length of 84" and a minimum gross weight of 26,002 pounds. Protruding knobs attached to the steering heel are

NOT permitted. A minimum 10' snow plow (measured at the bottom of the moldboard) mounted to the front of the vehicle is required. The salt/sand spreader must be mounted. Integral spreader and dump beds are accepted but must be in place. Material in the spreader box is not required, but is permitted if you choose.

Exams

This phase consists of multiple choice and true/false questions based on current driving rules, new CDL regulations, and safe equipment operations. Each member will take the test in a secured area with a proctor. Communications between teams and teammates is strictly prohibited while the test is in progress.

Training Information and Event Details

Flagger Certification. Two separate sessions are available for this training. This course will certify your employees for their ATSSA Certification.

CDL Training. The Kansas Highway Patrol will facilitate a hands on and educational course with a written exam. Participants will be tested in current CDL regulations.

Weather School. Learn from the meteorologists at Weather or Not how to interpret the many weather forecasting tools for your operational decisions: Internet maps, apps, NWS and television broadcasts.

The Calm During the Storm – Maintaining Effective Communication Between Operators and Technicians During a Snow Event. This class is for **BOTH** plow

operators and the mechanics who work on them. Participants will be educated on the steps they can take prior to and during a snow event to minimize plow downtime through

steps they can take prior to and during a snow event to minimize plow downtime through productive communication between the two. Learn the right questions to ask and the right way to frame answers to expedite repairs, keeping the trucks rolling and nerves calm.

Basic Welding a Torch Training. Airgas will be teaching the basics of welding and torch safety. Everyone will be eligible to compete in a competition/test in the afternoon.

Team Competition. This is an opportunity for your employees to combine their scores and compete as a team, there are no fees to compete as a team, but you must be registered in 6 of the 7 events. You must register prior to the start of the EXPO.

Equipment Events. Participants in all of the equipment events will have their skills and knowledge put to the test. All events will consist of a hands on operational test using their basic skills to maneuver equipment through a challenging obstacle course and an in-depth written exam based on current CDL regulations and safe equipment operation.

Caitlin Gard, MPA Assistant Public Works Director City of Shawnee, Kansas

Why did you choose public works as your career field?


